CHILDREN AND THEIR FAMILIES VISITED THE CENTERS MORE THAN 22,500 TIMES IN 2019, ALL TO BE TREATED FOR CANCER AND OTHER BLOOD DISORDERS. THE VALERIE FUND ALSO HOSTS HOLIDAY PARTIES AT ITS CENTERS DURING THE YEAR. HOLIDAY FUNCTIONS HOSTED BY THE VALERIE FUND DURING 2019 SERVED APPROXIMATELY 3,000 PATIENTS AND THEIR FAMILIES.
