CHILDREN AND THEIR FAMILIES VISITED THE CENTERS NEARLY 25,000 TIMES IN 2015, ALL TO BE TREATED FOR CANCER AND OTHER BLOOD DISORDERS.

THE VALERIE FUND ALSO HOSTS HOLIDAY PARTIES AT ITS CENTERS DURING THE YEAR. HOLIDAY FUNCTIONS HOSTED BY TVF DURING 2015 SERVED APPROXIMATELY 2,500 PATIENTS AND THEIR FAMILIES.

ADDITIONALLY, THE VALERIE FUND PROVIDES TRANSPORTATION AND FUNDING FOR 50-75 CHILDREN WITH CANCER AND BLOOD DISORDERS TO ATTEND OTHER CAMP PROGRAMS DESIGNED FOR THEIR NEEDS THROUGHOUT THE NORTHEAST.

THESE PARTIES BRING TOGETHER AS MANY AS 500 AT A TIME FOR JOYOUS HOLIDAY CELEBRATIONS WHERE PATIENTS CAN ENJOY THEIR CAREGIVERS IN AN ENTIRELY DIFFERENT SETTING. IT PROVIDES FUNDING FOR THE PSYHO-SOCIAL STAFF TO ATTEND NATIONAL CONFERENCES TO ENHANCE THE PSYCHOLOGICAL AND EMOTIONAL CARE OF THE CHILDREN UNDER TREATMENT AS WELL AS TO ACT YEAR ROUND IN SUPPORT OF THESE SAME PEDIATRIC PATIENTS.
