CHILDREN AND THEIR FAMILIES VISITED THE CENTERS APPROXIMATELY 25,000 TIMES IN 2012 TO BE TREATED FOR CANCER AND OTHER BLOOD DISORDERS.

THE VALERIE FUND ALSO HOSTS SEVERAL HOLIDAY PARTIES AT VARIOUS TIMES DURING THE YEAR. HOLIDAY FUNCTIONS HOSTED BY TVF DURING 2012 SERVED APPROXIMATELY 2500 PATIENTS AND THEIR FAMILIES.
